ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Dated Dispur, the, 2nd July, 2014

No.GAG(B)85/2008/139-140 : The Governor of Assam is pleased to make the following criterion as a basis for utilizing the Dispur Parade Ground at Dispur :

Norms for Using the Dispur Parade Ground .

1. General rules :

- (a) All applications for obtaining permission for using the Dispur Parade Ground/Field are to be addressed to Deputy Secretary to the Government of Assam, General Administration(B) Department, Dispur, Ghy-6 citing valid reasons. The field cannot be used until prior permission of G.A.Department is obtained.
- (b) Digging of field, erection of temporary/permanent structures or use of the field for smoking and consumption of alcoholic drinks is prohibited. Any violation may also attract action under law. Anyone found littering /soiling or urinating on the field will be fined ₹500/- (Rupees five hundred).
- (c) Driving classes and entry of any vehicles (without prior permission of GAD) is prohibited.
- (d) The field can be used for a period of 15(fifteen) days continuously by any organization/association after which the permission has to be renewed submitting proper application with G.A.Department.
- (e) Any Govt. or private association/organization will be allowed to use the field on rent basis amounting to as per rates shown below:

(i) Sports / Games/ Any other events	Government schools/College/ Office etc.	₹ 400.00
	Private schools/ institute/college	₹ 800.00
	Corporate houses/ Private organization	₹ 2000.00
For any other private purpose		₹ 3000.00

- (f) However in case of use of the field by any employees association under Secretariat Administration shall have to pay a rental at a concessional rate of ₹ 100/- per day. The payment as per rates shown above can be made directly by way of Treasury Challan. Necessary allotment orders will then be issued by GAD for the no. of days against payment made.

(g) G.A.Department will have the sole discretion to decide upon issues arising out of access to the Dispur Parade Ground. This will include access to the Parade Ground during wet conditions etc.

(h) G.A.Department shall engage necessary security and other personnel for maintaining the Parade Ground. S.A.Department shall provide the manpower to GAD for the purpose. Home Department will monitor the security issues regarding the Dispur Parade Ground.

2. Use by employees of the Secretariat : Any association comprising employees of the State Secretariat will have access to the field for holding activities only after obtaining due permission from General Administration Department. No individual requests will be entertained.
3. Sporting Events : The field can be used for holding sporting events with prior permission of General Administration Department. Players must be in proper dress code while on the field while making sure that shoes with spikes will not be used during wet conditions. The Parade Ground however will not be allowed to be used during wet conditions.
4. Use by other Organization/Associations : Any organization/association applying for using the field for any other specific purpose not mentioned above has to apply to General Administration Department. G.A.Department shall then pass necessary orders of confirmation/rejection at its discretion which shall be unanimous.
